# 2016 Annual Memorial Scholarship by Darlene Fetterhoff

Janet May, an English teacher in Streetsboro City Schools, not only excelled in the classroom, but also Janet's leadership in the 1960's and 70's resulted in exceptionally strong teacher contracts. She possessed qualities of intelligence, wisdom and foresight that motivated many of her colleagues.

Martha Hatcher, a music teacher in Southeast Schools, also excelled in the classroom, but her legacy lives far beyond. All who knew her recognized the exceptional musical talent she shared in her community, her church, and with both young and adult music students.

We are honored to recognize these two exceptional teachers in our 2016 Annual Memorial Scholarship.

#### PAY IT FORWARD SCHOLARSHIP by Dave Gynn.

To celebrate PCRTA's 50<sup>th</sup> anniversary, we are beginning a Pay It Forward Scholarship. Pay it forward is an expression for describing the beneficiary of good fortune by repaying it to others. The phrase may have been coined by Lily Hardy Hammond in her 1916 book In the *Garden of Delight*.

Our scholarship program began several years ago when we awarded one modest \$300 scholarship. The program has grown, and this year we will award seven \$1,500 scholarships. Funds have come from donations, memorials, proctoring and other projects.

Members are now urged to consider their good fortune to have retired from an honorable profession with some means to help future teachers through the PCRTA scholarship program. It is our hope this account will grow so we will always be in a position to continue the scholarship program.

PCRTA Scholarship is a 501c3 organization, and contributions qualify as IRS tax deductions. Contributors to the Pay it Forward Scholarship will be reported to the membership in these classes: \$1-\$49, \$50-\$99, \$100-\$249, \$250-\$499, \$500-\$999, \$1,000 and up. She leaves us with several concerns that we must continue to address. One of the most important ones is the creation of an ORTA Legislative Day at the Statehouse in late April/early May, 2017. 2017 will be a state budget year and items are often inserted that have nothing to do with the budget, but have a great deal to do with impacting retirees. We need to be fully involved in this critical process. This will help ORTA and all our members to maintain ongoing relationships with our local legislators. We all

must be willing to keep in contact with them especially when we are not asking for their support.

Even though we cannot be involved, as an organization, in endorsing candidates for political office, we can screen candidates for membership on the STRS Board. This is critical for us since the Board has a huge impact on our pensions, healthcare and the legislature. Pensions are mandated by the state but the Legislature can make changes to our pension system anytime they can get enough votes to pass whatever bill they choose. Remember how important DEFINED BENEFITS are to us.

#### PCRTA Executive Committee Meeting May 12, 2016

Vice President Georgia Darrah called the 501(c) 3 meeting to order followed by the 501 (c) 4 meeting. The minutes were approved.

Judy Morgan announced that the GED graduation will be June 9, and she will need help.

Legislative Chair Dan McCombs reported that Carol Kinsey, ORTA Legislative Chair, has resigned and said that she has been very good about keeping us informed. At the state legislative meeting it was emphasized that ORTA and PCRTA must remain objective politically. However, it is critical that we are aware of the candidates for the STRS board because they deal with our pensions, and legislation can change internal structures. Jim McGreevy and Bob Stein are good candidates. ORTA DAY at the statehouse will address budget concerns. ORTA suggests that we maintain contact with our legislators ALL THE TIME.

NEOMED Proctor Scheduling Chair Edith Scott reported that by the end of June we will have proctored 120 exams with 327 proctors donating 895 hours.

Pre-Retirement Co-Chairs Richard and Mary Ann Brockett reported on the Pre- Retirement Workshop which was held on April 16, 2016. The program included Judy Hendershot, who spoke on behalf of PCRTA; Lawyer Michelle Keith, who spoke on legal necessities for retirement; Investment Counselor Ray Kline who, spoke about maximizing income before retirement; and STRS Counselor John Buch, who discussed retirement income and health care issues. The program was well received by the audience. Twelve teachers attended. With spouses, friends, speakers and PCRTA members there were thirty in attendance.

Ron Snowberger gave the Trustee's report. He said the STRS program at Alliance was outstanding, but there were not many people there. STRS made it clear that our health benefits are not guaranteed—never were. The ORTA Board Conference is in the fall. It would be wise for people to attend. ORTA membership is critical in order to have influence on the legislature.

#### MEMBERSHIP NEWS

Fewer Portage County Teachers are choosing to retire from their classrooms this year. Several districts including Ravenna report no new retirees. That was almost to be expected after last year's mass exodus into retirement because of the changes STRS framed out for the next few years. So far we have sent letters of invitation to join PCRTA to 23 prospective members. If we are to reach our goal of 50 new members during this our 50<sup>th</sup> year anniversary, we need to look back to our colleagues who have retired over the last few years and not previously considered the benefits that ORTA and PCRTA offer. It has been mentioned before but bears mentioning again: personal invitation and word of mouth information produce far more results than a letter in the mail.

#### A LETTER FROM RACHEL BAUGHMAN, FORMER PCRTA SCHOLARSHIP WINNER- (2014)

I just completed my third year on the Rosebud Indian Reservation in South Dakota teaching 8th grade English at Todd County Middle School for the Rosebud Sioux Tribe. This year, I will begin teaching 8th grade social studies at McAuliffe International Schools for Denver Public Schools. I continue to love the teaching profession and the joy, opportunities and growth it provides.

Below, I've included an update email I send out to family and friends reflecting on my time as a teacher on a Native reservation. I hope it provides a bit more context and information about my experience. I continue to be thankful for the generosity of PCTRA and the incredible preparation I received from Kent City Schools.

#### Thank you! Rachel Baughman

My thoughts: I'm sitting in an empty classroom, save a half-eaten tin of cashews, my school bag and a stack of blank CDs. I've turned in my keys and received all of the required signatures for checking-out of the school building, and, subsequently, the school year. My feet are kicked up on my desk as I lean back in my chair, a position that feels like home, and assess my to-do list. It's a little after two in the afternoon; just shy of two hours before I pack up and walk out of Todd County Middle School for the last time until who knows when. The heaviness of this reality is settling in, bringing with it enthusiastic anticipation, a healthy level of fear and a tremendous, although perhaps not unexpected, amount of heartache.

As many of you have already heard, be it through Facebook, a conversation we've had at some point or another or the grapevine syndicate my mother runs out of her craft room, I've accepted an extraordinary teaching position at McAuliffe International School, part of the Denver Public School District in Colorado. Last weekend, three of my closest friends moved all of my worldly possessions to a third-story apartment with a Front Range view in Hampden and, in August, I'll begin teaching a whole new batch of 8th graders American history. I know I am ready for this transition and longing for the new experiences, new opportunities and new challenges it will provide, but it's still hard to go. It's really hard. Really.

Thanks to all of the lengthy drives I've taken in the past month, to and from the grocery store or to and from Rapid City, I've been provided with time to slowly and naturally reflect on all that the past three years have meant to me since I arrived, unknowing and terrified, but desperately yearning to do good, at my little periwinkle house with my roommate Katie. As I've tried to organize all of the thoughts, from the highlights that bring a bright smile to my face to memories of the darker moments, this quote keeps popping into my head. It was a selection I chose back in high school as a part of Kent Roosevelt's leadership retreat planning committee and has obviously stuck with me since (I guess Mother Theresa's powerful advice will do that to a person).
