LEGISLATIVE by Dan McCombs

I can't believe it is already Spring. It seems that the election season occurred many months ago. Day after day we see new headlines about what is or isn't happening in

Washington. It truly makes me wonder where we will be as a country over the next few years. We must get America to put party politics aside and do what is best for the country.

STRS reports that the Ohio Legislature passed Amended Substitute H.B.520. The bill included a measure that will allow benefits to be paid to a surviving child - regardless of their status in school - until age 22. It is interesting to note that The Ohio Retirement Study Council did not meet in January or February. The Council is made up of three members of the House, three members of the Senate and three gubernatorial appointees. The chairmanship of the council will reside in the House during the current General Assembly. The chair will be Senator Bill Beagle (R-Tipp City).

President Helena Parry called the 501c3 meeting to order. She read Scholarship Chair Jim Montaquila's report, which stated that applications for the 2017 PCRTA scholarships were hand delivered to all of the Portage County high schools. Kay, Ria, and Darlene helped Jim deliver them to all of the guidance counselors and principals. Last Friday he sent postcards to all of the guidance counselors reminding them that the due date for the applications is Friday, April 7. After that the committee will meet to make the selections.

President Helena Parry called the 501c4 meeting to order.

Recording Secretary Carole Stokes corrected the January 17, 2017, minutes to read as follows: There are 208 life members of both ORTA and PCRTA. There are 15 life members in PCRTA with an annual membership in ORTA and 11 life members in ORTA with an annual membership in PCRTA. Edie Scott made a motion to approve the minutes. It was seconded by Karen Balog. The motion passed.

Corresponding Secretary Denise Craig reported that she wrote an apology note to Rudy Bachna. In addition, she contacted Dick Ruch about helping on the Pre-Retirement Workshop Committee. He wants to do "hands on" activities. She also sent "notify now" to all members about POP 5. She said that the cost should be about \$23.33.

EXECUTIVE BOARD MINUTES continued

Vice President Georgia Darrah reported that all of the programs for this year have been set up and placed on our calendar. The speaker for the March program has been changed to Alan Kearns.

Dave Gynn reported on the Five Year Strategic Planning Proposal. He said the Restructuring Committee researched the organization in other states, which resulted in 14 suggestions to make it more convenient and efficient. The committee feels the need to replace the current by-laws.

Helena Parry gave the ORTA Trustee Report in which she stated that John Cavanaugh's focus is to use electronics to communicate. She reported that over 217 newsletters were mailed, and in March over 200 were emailed. She announced that May 9 is the ORTA 70th anniversary at the Columbus zoo.

Community Service Chair Judy Morgan announced that the project for May is the Coleman Center with donations of craft items: markers, coloring books, colored paper, paints, colored pencils, etc.

Membership Chair Judy Hendershot stated that she has nearly completed phone calls to all 40 members who had not renewed their memberships. Five have paid their dues, and one life member of PCRTA inquired about being a life member of ORTA.

Sunshine/Memorial Chair Judy Hendershot said that "Connie Evans and Karen Balog have created an outstanding Power Point program featuring (11) eleven members who have passed away since last year. To date two family members have responded that they will attend: Pat Bateman and Kathy Lilley. Letters inviting family members of those to be honored were mailed in early February. There were five deceased members who had no local contacts." Judy also said that Patty Miller has volunteered to assume some responsibilities for the Sunshine Committee.

NEOMED Proctoring Chair Edie Scott stated that she needs a few more people in the near future.

Protective Services Chair Kay Wise reported that she and her husband Ralph participated in the AARP Driver Safety Program in Tallmadge and saved \$77.00 on their car insurance. She also announced that St. Patrick's Day weekend will be the Reed Memorial Library book sale.

Public Relations Chair Georgia Darrah reported that the news release about the March luncheon was published last week. Also the news release alerting high school seniors that they can apply for a PCRTA scholarship if they are planning to go into education should be in the newspaper soon.
