## The November Luncheon Speaker Is Mike Kerrigan

Mike Kerrigan first joined the staff of the President's Office of Northeast Ohio Medical University (NEOMED) in October 2011 and currently serves as Community Relations & Special Initiatives Manager.

In this role, Mike's primary function is to develop, implement, manage and evaluate all aspects of the University's community relations activities in support of NEOMED's mission and strategic plan. In doing so, Mike provides professional support for community



outreach programs across all university colleges and departments and represents the university's interests as liaison to committees, organizations and community groups both within and outside NEOMED. Mike's work has been instrumental in creating synergistic partnerships with business, government and non-profit organizations at the regional, county and local level--further strengthening NEOMED's town-gown relationship, as well as its stature as a regional economic engine.

Furthermore, Mike directs the implementation of university-wide special initiatives. Of note, Mike is one of the founding (and still active) board members of Bio-Med Science Academy STEM School, the first rural STEM school in Ohio and the first STEM high school on a medical university campus in the nation.

In the community, Mike serves as the vice president of the Rootstown Area Chamber of Commerce and is a member of the board of the Kent Area Chamber of Commerce and the Medina Hospital Community Advisory Board.

Prior to NEOMED, Mike served in both the Capitol Hill and Ohio district offices for a former member of Congress and was previously federal relations associate for The Ohio State University's Washington, D.C. office. Mike holds a Bachelor of Arts degree in political science: public policy focus from The George Washington University and is in the process of obtaining a Master of Public Administration degree from Kent State University. Mike will be speaking about the new programs at NEOMED.

## IN LOVING MEMORY

**Richard Rymer**, a life member of ORTA and PCRTA since 1994, passed away on July 17. He worked for the National Bureau of Standards in California. He was an electronics technical representative to a company in Germany and taught electronics to the German Air Force. Preferring to work with people, he became a psychologist and taught at the University of Akron from 1970 to 1993. He and his wife were active in the Kent Historical Society, several nature organizations and antique car clubs.

Alice Darr passed away August 21, 2014 after a courageous battle with cancer. Born and educated in Illinois, she moved to Ohio to join the Kent State University faculty. She was a coordinator of the Home Economics Ed. Program and co-chair of the KSU commencement committee for 25 years. 
