The students selected seemed sincere, intelligent, well spoken, and well educated. The process for selection is a planned and methodical method, which consumes many hours of the committee's time.

Then, how encouraged and delighted I was to meet the scholarship winners at our last two PCRTA luncheons. During the July luncheon meeting, everyone seemed to enjoy the recipients' answers to several questions asked of them during a panel format. The answers to many of these questions are found in the minutes of the July meeting written by Ruth Weigand. (Look on www.pcrta.net.)

I thought that you might be interested in hearing some of our own membership respond to the same questions asked of the scholarship recipients. Here are their answers:

Why did you choose the school you did?

Georgia Darrah: I chose Kent State University for both my undergraduate and graduate work because they had an outstanding reputation for training teachers; and I wanted the experience of living on campus, but not be hours away from home.

Ruth Weigand: I chose KSU because I received a four-year tuition scholarship which I gave up to attend the cadet program, a two-year and two-summer training program at KSU which enabled me to begin teaching while finishing my degree.

Helena Parry: I, too, believed that KSU had a great teacher training program in the 60's, and I received a \$360 scholarship from the Junior Chamber of Commerce which paid for six quarters of tuition.

Jim Montaquila: I attended Ashland College (now Ashland University) for my B.S. degree because it was a small school and they provided the personal care I needed at that time. I received my M.S. degree and further advanced education from the University of Akron. It had the programs I needed and wanted and was convenient to me.

What was your most memorable high school experience?

Georgia: It was being a part of the Alliance High School Marching Band. We worked very hard under our leader's direction, and we knew that hard work paid off.

Ruth: My most memorable experience was being chosen to go to Ohio Girls' State.

Helena: I had two things that were really hard to choose between: getting the Womanhood Award as a senior and being Miss Portage County Queen in 1961.

Jim: At my high school graduation, I received the School Spirit Award. It was one of the two highest awards presented to graduating seniors, and I had worked for it during my entire high school career.



Which teacher had the greatest positive influence on you?

Georgia: My band director taught us to set high goals and then work to achieve them. He instilled a work ethic in them and allowed us to see what we could accomplish with hard work and dedication. Ruth: My ninth grade Latin and English teacher had a huge influence on me because she convinced

my mother that I needed eveglasses.

Helena: My most influential teacher was my first grade teacher who allowed me to tutor others and to help a needy student to get organized.

Jim: Ray Brannon was my high school football coach. He always spoke of giving that "second effort." In one word, that meant persistence.

Why did you choose to go into education?

Georgia, Ruth, and Helena: All three women said they knew they wanted to be a teacher from when they were very young. Georgia played school with her friends; Ruth taught her brothers and sisters; and Helena played school with her dolls lined up on the stairs to the second floor.

Jim: I loved social studies and felt that the teaching of history and government would be something that I would truly enjoy. As a young man, I remember my mother encouraged me

to go into education and get my teaching certification. She said it would always be something that I could fall back on. Well, I certainly did that. Still working with kids for the five years after I have retired and spending thirty-four years in schools, I think I accomplished what my mother suggested. There is no profession that touches as many people as does education. Both in the classroom and in administration, you have a permanent effect on everyone.

LOOKING AT THE CHANGES IN THE BUDGET BILL—PROMISES FORGOTTEN

How long before we get a budget bill from Columbus that will provide will make retired teachers happy?

HB59 contains many changes to tax policy that will provide approximately a \$2.6 billion tax cut over the next three

Bruce Hodges, the ORTA Legislative Chairperson shared the following tidbits from the latest budget bill:

Knowledge of the bill will enable us to better prepare for our futures. We must continue lobbying and voting for people who respect our positions on legislation.

The K-12 funding portion of the bill was increased in conference committee. However, even with these additional resources, the budget is approximately \$515 million short of restoring the \$1.8 billion in reductions that school districts experienced as a result of the last budget cycle.

Another major setback in the budget is the expansion of vouchers. This proposal expands vouchers statewide even in the highest performing school districts. About 2,000 vouchers are funded for the 2013-2014 school year with the amount doubling in the following year.

The budget bill also included a section on teacher evaluation where student growth will make up 50% of a teacher's evaluation.

HB59 contains many changes to tax policy that will provide approximately a \$2.6 billion tax cut over the next three years predominately for the benefit of higher income Ohioans. This will reduce the available revenues used to fund vital state supported programs. The top 1 percent (\$335,000 and over) on average will get tax cuts of more than \$6,000 a year and the bottom fifth of Ohioans will pay \$12 more per year.

Finally, the new law limits the application of the 12.5% property tax rollback by not applying the rollback to newly voted/new or replacement levies that become effective in or after tax year 2014. Earlier passed levies will still be

subject to the rollback. This will make levy passage much more difficult. We need to remember that the legislature promised the rollback when they passed the state income tax!!! How times change and how soon we forget promises.

Remember how important our membership continues to be in letting our representatives know we represent a lot of retirees. Keep up the good work and continue to contact our

representatives with our opinions. **Dan**

MEETING MINUTES - Ruth Weigand, Secretary



Highlights from the last Executive Committee and the luncheon meeting are provided below. Many meeting details are included in other reports in this newsletter. EXECUTIVE BOARD MEETING - July 11, 2013

--President **Helena Parry** presided. Seventeen members were present.

Guests **Phil Faluotico** and **Stephanie Rummel** came to encourage retired teachers to volunteer for United Way. They need volunteers to serve on the United Way Campaign Committee. Webmaster **Connie Evans** said she would put the information on our website, or members can call 330-297-1424 for more information.

- --Recording Secretary **Ruth Weigand** asked the board members to give her their written report to make sure she gets all information correctly. **Kay Wise** moved to accept the minutes, seconded by **Mary Ann Brockett**, and the motion passed.
- -Corresponding Secretary **Barb Cribbs** sent out 40 letters to former scholarship recipients and received 8 responses. She will put the replies on the tables at the luncheon.
- -Treasurer **Darlene Fetterhoff** reported that we have a \$9,695.16 balance in the checking account, which includes \$3,881.50 for scholarships, leaving a working balance of \$5,813.66. She said \$850 was transferred from scholarship to checking to provide funds for getting the 501c3 designation.
- -Darlene reported that as of June 30, 2013 our investment account at Stiffel Nicholas has \$44,616.03 for scholarships. The report was filed for audit.
- -Vice-President **Georgia Darrah** went over the plans for the scholarship luncheon and the September luncheon. She and **Judy Morgan** went to visit the Giving Dolls office and said she things we will really enjoy her program.
- -President **Helena** said that **Gary Devito** from AMBA will be at the scholarship luncheon to speak about benefits.
- ORTA Trustee Ron Snowberger reported that ORTA has a slide presentation available to encourage new members.
 He serves on the ORTA Public Relations and Legislative Committees.
- -Community Service chair **Judy Morgan** said that we would be collecting school supplies in July and items for the Giving Dolls at the September luncheon.

- -Judy Morgan also reported that members have turned in 3,900 volunteer hours so far this year.
- —PCRTA Legislative Chair **Dan McCombs** reported that the legislation for the GPO/WEP for social security had been reintroduced. He said it will be harder for schools to pass levies, because the 12 1/2% reduction on property taxes has been eliminated. The budget bill was 1,500 pages long and included teacher evaluations and increased money for charter schools, even though they are failing.
- —Membership Chair **Dave Gynn** said that our ORTA trustee position is terminating this year, so it is important to keep our membership numbers up because the 10 largest chapters get a trustee. We had 20 members who did not renew their memberships this year for several reasons.
- -Proctor Scheduler **Edith Scott** needs more people to volunteer as proctors. There is a new proctor orientation meeting on August 14 at NEOMED.
- -Newsletter Editor **Pat Gynn** reported that 98 members got email notifications to find the newsletter online at our website and 314 newsletters were mailed out at a cost of \$300.42. **Judy Kirman** will take over distribution of the email newsletters.
- -Nominations Chair **Jan Fencl** said that elections for Vice-president, Recording Secretary, and Treasurer occur in the odd-numbered years. Officers will be elected at the November meeting and take office in January.
- -Jan announced the resignation of Darlene Fetterhoff as Treasurer for several years and thanked her for her outstanding over-the-top service.
- -The slate of officers for 2013-2014 include: **Georgia Darrah** as Vice-President; **Ruth Weigand** as Recording Secretary; and **Dave Gynn** as Treasurer.
- -Pre-Retirement Chair Mary Ann Brockett said the seminar will be held April 13, 2014 from 5-7pm at Western Reserve Media. She said the presentations would be the STRS presenter and Attorney John Flynn. We will not have an investment presenter.
- -Protective Services Chair **Kay Wise** said that **Dr. Stacy Schneider** will have her students at the luncheon to take blood pressures.
- -Public Relations Chair **Georgia Darrah** said she would take pictures at the luncheon for the Record Courier.
- —Scholarship Jim Montaquila said that Georgia Darrah and Connie Evans are making a power point presentation about the scholarship recipients for the luncheon. The students and their families will be seated at different tables. The recipients will participate in a question-and-answer session. Jim said that since the beginning of the PCRTA Scholarship Program through 2013, a total of \$49,200 has been awarded to 87 deserving students.




