




## Portage County Retired Teachers

### 2009 SCHOLARSHIP WINNERS HONORED

Six outstanding high school seniors who plan to become teachers will be honored at our July 16 luncheon. The scholarship committee reviewed 12 applicants from Windham, Kent Roosevelt, Southeast, Streetsboro, Rootstown, James A. Garfield, and Ravenna high schools who applied for the \$1,000 awards. Congratulations to Cody Apthorpe, Kaitlyn Briggs, Brandon Broadwater, Emily Mason, Taylor Polatas, and Courtney Spellman who will be our guests on July 16.

It is not surprising that all applicants excelled in academics; participated in many school and community activities; and were leaders in clubs, sports, and activities in and out of school. Teacher recommendations praised these future teachers and predicted unusually high performance in college.



**Cody Ellis Clark Apthorpe** hopes to teach junior high science and coach basketball after earning his degree at Bowling Green State University. He uses his landscaping skills to plant memorial trees at school and in public parks, and he volunteers with a local garden club. He also volunteers as a youth basketball coach, sings at nursing homes, and rings bells for the Salvation Army. While taking a rigorous schedule at Windham High School, Cody was a three-season athlete, an officer in National Honor Society and student council, and took part in many extra-curricular activities.

Kaitlyn Briggs demonstrates enthusiasm, a positive attitude, a unique personality, and an optimistic outlook which will help her make physics classes come alive when she begins teaching. ## HOW OUR SCHOLARSHIPS ARE FUNDED

PCRTA's first scholarship was \$100 granted in 1994. The amount was increased to \$200 in 1999, \$300 in 2002, \$500 in 2006, and to \$1,000 last year. Seventy future teachers have received PCRTA scholarships. Money for books and expenses is helpful, but the recognition and support are significant to students planning to become teachers. We are one link in the future of these potential teachers.

Our scholarship fund is supported by contributions, memorials, and volunteer efforts. Northeast Ohio Universities College of Medicine and Pharmacy makes a significant contribution to the fund in appreciation for our members who volunteer to proctor tests.

**Contributions** are often made to the fund by members who see value in supporting these future teachers. Some people add a little extra to their luncheon reservations designating the extra money to go to the scholarship fund. Other members send direct donations. Making a **memorial contribution** is a worthy way to leave a lasting tribute. This year memorials have been made in the names of **Mabelle Apley**, **Theresa Bica**, **Carol McGill**, **Betty Murray**, and **Virginia Patton**. Money was also contributed to the scholarship fund from the estate of **Mabelle Apley**, a PCRTA member who retired from Kent City Schools.

Consider the PCRTA Future Teacher Scholarship Fund when you do your estate planning. If an obituary requests that memorials be made to PCRTA, the notice should include the address of the current treasurer. A card will be sent to acknowledge all memorial

contributions. Consult your financial planner or attorney to designate a portion of your estate for this worthy purpose.

Memorial gifts will live in perpetuity.

### LEGISLATIVE REPORT by Dan McCombs

Just a quick note to inform you that according to 4. Will it be a public or private plan (or a Jim Miller, STRS Federal Consultant, the Government Pension Offset Bill will not be addressed this year. The chairman of the committee, John Tanner, of Tennessee, (a Blue Dog Democrat) and ranking member, Sam Johnson of Texas are not supportive. There would be an 80 billion dollar cost for this program over a ten-year period. This bill has been introduced each year since 1987 without passage.

Jim Miller was one of our speakers at the Spring ORTA conference in Columbus. He tells us that a Health Care Reform Bill is on a fast track due to Senator Kennedy's own poor health. Kennedy wants this bill passed as part of his legacy. There are plans to have the bill on the floor for discussion as early as July. It will only need 51 votes in the Senate for passage due to its fast track status.

Questions yet to be determined are:

- 1. Who will have access?
- 2. What will be the cost?

combination of the two)? and finally... 5. What will be the implications for STRS?

Did you know that an STRS retiree gets benefits for an average of 26 years after retirement? Employee contributions pay for 3 years, while Board of Education contributions pay for 6 years. The rest of the time is paid for by investment income.

Finally, Jim tells us that Social Security reform will not happen this year, but Medicare reform might. On a scary note, as the

funds of these agencies become depleted, the Federal Government will be looking for new ways to fund them. This means that mandatory coverage of all teachers will probably be back on the table.

### PREZ SAYS: FACING PENSION AND HEALTH CARE REFORM By Ray Troxtell

We need to be

We are being confronted with a number of financial issues today as a result of the longevity revolution, rapidly rising medical costs of healthcare, and a drop of investment value and income.

Here in Ohio, our five public retirement systems pay out \$800 million monthly to retirees plus \$8 million daily for health care for members. This is big business even by Washington D.C. standards. STRS pays \$69 million plus annually to retirees in Portage County.

The average STRS retiree lives 26 years in retirement. Their personal

contribution pays for three years of retirement income, and the contribution from their school's Board of Education pays for six years. The balance is paid from investment income.

Our Ohio Legislature is presently preoccupied with the budget for the next two years. We are receiving information that they are now ready to turn their attention to reforming the pension systems of Ohio.

Some of the ideas regarding STRS are:

- Reducing the amount given for COLAs cost of living adjustments
- Extending the age of retirement to 60 or older
- Reducing the 35-year incentive back to what it was before
- Reducing the cost of health care to the pension system

There is nothing that is not subject to their interest. We need to be vigilant and not be closed minded, but be willing to be flexible. The public is full of "pension envy." Remember that politics has nothing to do with what is logical or rational. Politics will win most of the time.

We have been seeking a stream of revenue to fund our rapidly declining health care stabilization fund. There have been some health care plans introduced in Congress, and they should appear on the floor by July, 2009. A simple majority in each house is all that is needed to pass the bill in Congress.

The question appears to be whether it will be a public plan or a privately-administered plan. We have not any idea of the impact on public and private health plans and their payrolls. Polls indicate that most people think that a health plan

> with prescriptions for a family should not cost them more than \$100 dollars a month.

The best way to communicate with the legislators is through Email followed by a phone call to let them know that you have Emailed your thoughts to them. Since the threats of anthrax, letters are generally thrown out without ever being read.

We must educate legislators on the

issues they are facing. We need to be part of the solutions or they will control our retirement funds. A "No Way" attitude puts us at a great disadvantage. Do not threaten or try to intimidate them. It just doesn't work.

The proposed repeal of the Social Security Pension Offset Provision has many sponsors in both the Senate and the House. Despite the large number of sponsors each year, it never makes it out of committee. The increased costs of Social Security and Medicare fuels the idea of mandatory Social Security coverage for everyone.

The idea of forced mandatory coverage for everyone would destroy many public and private plans due to the costs to every state. Every state has pockets of non-mandatory coverage—usually police and fire pension plans. The real issue for repeal is one of equality. Under Social Security, a spouse who has not contributed to Social Security may draw half of the spouse's benefit; and upon the death of the spouse, they receive the full benefit. This is not true of our pension plans.

We will try to keep each of you informed, but the situation in Washington, D.C. is fluid and changes almost daily. Call us if you have questions or concerns.

On a more uplifting note...the NRTA has presented 15 national awards and ORTA chapters have received five of them. Congratulations!

### WHAT TO DO ABOUT THE FLU

The current flu virus has not been called a pandemic. That means it is a newly emerging infection that is able to cause serious illness in humans and can be easily spread from person to person. We can take action to prevent a spread of the flu.

>>Wash hands frequently. Use soap and water or alcohol-based cleaners to prevent transmitting viruses that normally get stuck on the hands in day-to-day activities.



>>Avoid touching your eyes, nose, or mouth. Germs spread that way.



>>Avoid people who cough and sneeze. The Center for Disease Control (CDC) recommends people cover their nose and mouth with a tissue when they cough or sneeze, then throw the tissue in the trash. Flu is spread primarily through coughing and sneezing.

>>Stay home if you experience flu-like symptoms. The CDC recommends limiting contact with others to keep from infecting them, especially if you have been to Mexico recently.

>>Rethink your plans for traveling to Mexico.

>>Plan ahead. Stay informed about what is happening in the community and follow instructions from reliable sources.

Many thanks to the following members who have volunteered to be on the Membership Committee this year: Jane Bridge, Tom Campana, Adele Fussner, Merrielu Ritz, Carol Rudlosky, Saroj Sutaria, Gordon Weber, and Kay Wise.

The PCRTA Executive Board suggested that some changes should be made to *our new color brochure* before the master went to the printer. We sent the board's recommendations to the designer, Jeff Kirby, who made the changes. The new brochure came back to us by Email in a PDF form that the printers requested. When we asked for estimates for printing the brochures, we were amazed at the difference in prices. The lowest cost (and the one we

chose) was 49 cents each, and the closest to this was 77 cents. But some of the estimates were over a dollar each.

We now have received the revised brochures and are ready to start our mailing. We are still hoping that we will receive an STRS updated list of those retired teachers who reside in Portage County, but if it does not arrive, we will use the list from last year and update it.

We are always looking for *reasons to induce new retirees to join our organizations*. There is one reason that does not apply to all retired teachers, but it does affect a sizable number, more than we had suspected. We have had complaints not only from STRS members but also from PERS retirees who also worked under the social security program. They feel that the legislation that reduces their Social Security payments just because they are part of a public retirement system is grossly unfair. ORTA has been trying to get the *Social Security Fairness Act of 2009* passed by the House of Representatives. We think potential members of PCRTA might want to help with this effort. They can do this by joining the retirement organizations. The *ORTA Spring Quarterly* has provided a model letter that can be modified and sent to legislators, but this contact information was not available to non-members. The Membership Committee feels that a *unified effort* is our best bet to get this legislation passed.

> Other issues we ask potential members to consider when they are thinking about joining, are the rapidly rising costs of health insurance and the fluctuations of the stock market that affect everyone's pension; plus there are services like long-term care, dental and vision plans, and the newest insurance now available for emergency transportation that are available to members.

We realize that there is just *no substitute for personal contact* when it comes to maintaining or

increasing our membership. And although this has a nice sound, it has proved to be a very difficult if not an impossible task. What we have done is to enclose a personal letter with each application; in the letter we emphasize the many benefits of membership. Near the close of the letter, we use the phrase that we hope will be effective again this year:

#### "We really do need you, and you really do need us."
