Selected from 23 applicants, the winners demonstrate excellence in scholarship, community service activities, and leadership experiences. Congratulations to Katelyn Alesci (Streetsboro), Kyle Dreger (Rootstown), Molly McCreary (Kent Roosevelt), Miranda Titko (Field), and Alex Wolfe (Waterloo). They will be introduced at our July 15 luncheon.

Katelyn Alesci was the president of her class at Streetsboro High School. She has been involved in the school-to-work program allowing her to gain teaching experience with elementary and middle school students and their teachers. Her supervisor said, "Her many strong points include her intelligence, commitment, and enthusiasm. She is able to effectively adjust to changing lesson plans and 'jump in' in a highly productive way." She is a nursery attendant at her church and has participated in a mission trip to New Orleans. Katelyn will attend The Ohio State University and looks forward to their "study abroad" program to learn about different cultures.

The top graduate at Rootstown High School, **Kyle Dreger**, plans to attend Mount Union College and major in education and computer science. As an IT intern, he helped kindergarteners learn to use computers while assisting staff with technical problems. He is the founder and CEO of "Laps for Love Charity Walk-a-thon" to help cancer patients and their families with the financial burden that comes with ever-constant medical bills. Kyle participated in Buckeye Boys State and was captain of his soccer team. He teaches Sunday School and Vacation Bible School. His English teacher stated, "He is one of very few students I have ever encountered to possess the moral, academic, and personal characteristics that set him apart from his peers."





Music has always been important to **Molly McCreary** who was the field commander for the Kent Roosevelt marching band. She was a section leader in the orchestra, played piano in the jazz band, and has been dancing competitively for 12 years. Her band director reports that, "Miss McCreary's hard work, dedication, talent, and academic excellence will make her an excellent representative of this scholarship." She was the booster club president and the orchestra librarian. She teaches Sunday School and Vacation Bible School. Molly will attend the University of Akron as a music education major. Because she will begin college with 23 credits earned while in high school, Molly will finish a five-year music education degree in four years.

Miranda Titko ranks second in her class, is a class officer, president of Field High School student council, a teen board representative, and captain of her soccer team. She will attend Kent State University and study integrated mathematics. Her advanced placement English teacher calls her "logical, perceptive, organized, and ambitious—an intellectual star in the classroom." She is a member of the "homework gang" at her church where she volunteers to help students with their math homework. Miranda teaches Vacation Bible School and has gone on mission trips with her church. She was recently touched by the loss of her brother to cancer. Her dream is to teach and spread her love for learning to her students who may someday follow their dreams and find an end to this ugly disease.





Alex Wolfe will attend Mount Union College to study mathematics education with a minor in adolescent to young adult education, and he plans to teach high school math. Graduating third in his class at Waterloo High School, he received the Bausch & Lomb Honorary Science award. He participated in Quiz Bowl, Beta Club, Drama Club, and was the design editor for the school paper. He was in the school marching, symphonic, jazz, and pep bands. His teacher makes this recommendation: "By virtue of his intelligence, curiosity, and diligence, Alex does well in challenging academic endeavors." He also offered, "It always pleases me when a bright and talented student chooses to enter the teaching profession." Alex plans to show his students the relationship between math concepts taught and where they are applied in real life.

PREZ SEZ - ELEVATOR GOING UP by Dave Gynn

Have you crafted your elevator chat?

An elevator speech or elevator pitch is a concise, carefully planned, well-practiced description about your cause. Some people think of it as a brief, easy-to-understand message a person would comprehend in the time it would take to ride up an elevator.

Sales people rehearse their elevator presentations. They stress the importance of how their product or service will meet the needs of potential clients—in just the time it takes to ride up in the elevator.

I hope you will use your elevator speech or elevator chat to encourage PCRTA and ORTA

membership. What do you say when you meet a non-member—a recent retiree or someone who just hasn't joined yet?

Your prepared elevator chat will pop into your head, and you will talk confidently about their need to participate in the only retired teacher organization in Ohio working to improve the benefits of retired educators. Your chat should mention that Ohio legislators will soon be making changes to the retirement system, and future retirees may not receive the benefits we are enjoying. We need to speak in one loud, clear voice that our STRS system must **not** go to a 401K-type retirement plan.

All STRS recipients must let Columbus know that retirement without health care is not

retirement. Retirees should remind legislators that our annual cost of living adjustment gives us the security needed in retirement.

A goal of your elevator chat should be to have non-members sign **UP** for membership. We need to bring our membership numbers **UP** to become a more significant voice for all active and retired teachers.

Teachers are natural story tellers. They need to be prepared when the see non-members and deliver their elevator chats. Membership will go UP. Our influence will go UP. Our elevator should always go UP.

WE NEED TO KEEP OUR DEFINED BENEFIT PENSION SYSTEM

We need to be ready to respond to the current financial shortfall in our State budget. The latest figure I have been hearing passed around Columbus is that we are facing an 8 billion dollar deficit for next year.

Since the State cannot operate with a deficit, cuts in expenditures will have to occur or new sources of funding will have to be developed. When is the last time you recall a legislator or governor having enough backbone to utter the TAX word. I don't think I will ever see it in my lifetime.

So where might the politicians look to borrow the funds to cover the shortfall? You've got it...our pension system.

We need to be proactive in letting our representatives and our Governor know that we will not permit them to raid our pension system. Even though they will tell us that they will pay it back, I personally am skeptical that they would do so.

Now is the time to act, not when the horse is out of the barn. Write, call, or e-mail them to let them know you want our pension systems protected at all cost. There continues to be a lot of pension jealousy out there in the public regarding our system.


There is a movement afoot to get us to switch from our current *defined benefits plan* (where we get a defined stable source of revenue) to a *defined contribution plan* (a 401k-type that depends on the stock market and the economy).

National studies have recently found that our defined benefit plan can be run for nearly half the cost of a defined contribution plan. West Virginia made the switch only to lose money for teachers and chose to go back to the defined benefit plan.

In closing, I want to continue to remind you that we need to also continue our fight to keep our pension system out of Social Security. These our tough times, but with your help, there will be better days ahead.

Wouldn't it be refreshing to read about positive changes in education rather than these difficult economic realities.

One of the very nice things that happened to the Membership Committee lately was to have **Adele Fussner** join the group. The first task Adele undertook was to phone some of the latest PCRTA members and welcome them into the association. It is so important that new members feel welcome. No one else is better suited for doing this than Adele. We want to thank Adele for volunteering to help.

The most important news from ORTA is that ORTA annual dues will increase from **\$20 to \$30 after DECEMBER 1**, and life membership will increase from **\$300 to \$500 after SEPTEMBER 1**.

Talk about change! This is a large increase in ORTA's dues; however, it is the first increase in ten years. We were reminded of Heraclitus, the Greek philosopher, when he wrote "nothing endures but change." Or even my wife's favorite Robert Burns' quotation from *To a Mouse:* "the best laid schemes of mice and men aft go agley."

Our original committee plan, in addition to contacting the 62 teachers who retired this year, was to concentrate our efforts on retaining our present members and to contact teachers who reside in Portage County and have not yet joined the PCRTA and to ask them to consider membership.

The sudden news from ORTA about the increase in dues meant that we had to drastically revise our plans. There was not

enough time to assemble the entire committee, so Helena Parry, President David Gynn, and I met and made plans for making the changes.

The 62 new retirees had already received invitations to join the associations, but none were notified that there would be an increase in dues. We decided that we needed a new package of materials to be distributed to every school in the county BEFORE the start of summer vacation.

In the packet for each school, we planned to include our "Ohio Major Newspapers Put Public Pensions Under Attack" collage, a copy of the latest ORTA quarterly, and posters for the bulletin boards that listed the changes in dues. We also included a letter from **David Gynn** with the title "Preparation for Retirement" and some of our current applications, where our current dues are listed. We also added a notice for the upcoming Pre-Retirement Workshop scheduled for October 19 at the United Methodist Church in Kent.

Thanks to the cooperation of the staff at the Educational Service Center in Ravenna all the packets were delivered through their inter-school service.

One has to hope that the efforts of the committee will help to maintain and even increase our membership.

MEETING MINUTES - Ruth Weigand, Secretary



Highlights from the last Executive Committee and luncheon meetings are provided below. Many meeting details are included in other reports in this newsletter. EXECUTIVE COMMITTEE MEETING - May 13, 2010

--Corresponding Secretary, **Barbara Cribbs**, mailed 22 letters to former scholarship recipients and received seven responses for the newsletter.

--Darlene Fetterhoff reported a treasury balance of \$18,181.45 (\$4,571.21 working balance and \$18,181.45 scholarship fund). Expenses included newsletters, \$347.76; scholarship printing and mailing, 95.37; postage, 24.40; 2010 audit and 990 form, 150.00.

--Vice-Presidents, **Ken & Nancy Granville**, reviewed the luncheon programs. **Dan McCombs** will arrange a meeting to meet the candidates in the November election.

--ORTA Trustee, **Dan McCombs**, reported that the revised bylaws were approved. The number of trustees will be reduced; Portage County needs a large membership increase to retain a trustee. He also reported that ORTA dues will increase to \$30 a year; life membership will increase to \$500.

--Results of a survey at the March luncheon show that most members are satisfied with the location, time, and program of PCRTA luncheons. Most members attend to meet people, legislative concerns, and programs.

--Ten PCRTA members attended the ORTA Area Meeting in Canton. They reported on the workshops and how to improve PCRTA. Jim McGreevy and Bob Stein, STRS Board members, impressed delegates with their reports.

--Unfinished Business: The adhoc bylaws committee will review the revised ORTA bylaws and recommended changes to the PCRTA bylaws.

--Norm Park recommended that our records be stored in places such as Portage County Historical Society so they are available to interested parties.

--Judy Morgan, announced that the Maplewood GED graduation date has been changed to May 27. PCRTA

members will supply cookies and act as hosts to serve refreshments. We will also prepare congratulations cards for the graduates. She also reported that six PCRTA members served as judges at the Future Educators Association contest in April at KSU.

--Kay Wise said Bisslers will provide estate and funeral planning brochures for the memorial services luncheon. Miracle-Ear Hearing Center will offer hearing checks at the September 16 luncheon.

--Legislative Chair, **Dan McCombs**, said not to expect retirement legislation until after the election. There is a need to stress that STRS pensions should remain as a defined benefits program. ORTA is supporting a push for the US Congress to pass the GEO/WEP legislation.

--Art Fesemyer reported that there are 60 retiring teachers in Portage County this year. He sent membership packages and will send notices about the dues increase.

--Mary Jane Brannon, said everything is ready for the memorial service luncheon. She asked to be notified of any member illnesses or deaths.

--**Pat Gynn** reported that 410 newsletters were printed and 370 mailed at a cost of \$347.76. Thirty newsletters went to Membership for recruiting new members.

--Edith Scott reminded members to sign up for NEOUCOM proctoring. The next orientation will be in August.

--Jan Fencl reported that Ria Mastromatteo (Assistant Treasurer) and Barbara Cribbs (Corresponding Secretary) have accepted nominations for 2011-2012. There is no nominee for president at this time.

--Helena Parry has scheduled the Pre-Retirement Planning seminar for October 19 at the United Methodist Church of Kent.

--Jim Montaquila said 23 applicants from nine Portage County high schools were considered for scholarships. The committee selected six seniors to each receive a \$1,000 scholarship. He also received a check from the estate of Mildred Price which she designated for our scholarship fund. Jim met with the Portage Foundation and learned that by investing our funds with them, we would give up the principal and be entitled to withdraw only the interest.

New Business: It was suggested that we have a mini-fair at one of our meetings. Each committee would have an exhibit to show what the committees do and to encourage volunteering on a committee.



LUNCHEON MEETING - May 20, 2010--

The PCRTA luncheon meeting was held at the United Methodist Church of Kent.

--Ken and Joanne Cardinal were the greeters. Music was led by Les Bennett. The invocation was given by Rev. Heller.

--President **Dave Gynn** announced that today's community service collection was for Freedom House, a residence for homeless veterans. He asked members to write some congratulations cards for Maplewood GED graduates and to sign up to bake cookies for the GED ceremony.

--Jerry Weingart spoke on behalf of AMBA, Association Member Benefits Advisors, who are endorsed by ORTA. He said they offer long-term health care, cancer insurance, a travel program, and many other services.

--Bissler's Funeral Home provided estate and funeral planning brochures.

--Mary Jane Brannon prepared a table with obituaries for the deceased members from the past year. **Rebecca Heller**, First Christian Church minister in Kent, led the memorial service by using rocks as a symbol for remembering our loved ones. There was a moment of silence for each of the ten deceased members; namely, Mary E. Baker, James Caniglia, Dorothy L. Franks, Irene George, Clinton H. Hobbs, Eric May, Mildred P. Price, Raymond Troxtell, Dorothy A. Turk, and Doris T. Wise.

-- Dan McCombs said there is a major concern in Columbus because the state of Ohio has a deficit of 8 billion dollars and we need to watch closely for their attempts to borrow from the pension funds. He noted that the stimulus money is helping this year. He stressed that it is vital that STRS members realize that they want to maintain the defined benefits retirement plan and not switch to a defined contribution plan.

The 50/50 drawing in the amount of \$54 was won by **Nancy Granville** who donated back to PCRTA.

Dave thanked everyone on the Executive Committee for helping to make our organization successful. He thanked everyone who attended the meeting and asked them to each recruit one or two retirees to attend our meeting and also to thank the legislators for our defined benefits retirement plan.

KEN CARDINAL IN HALL OF FAME


