
Can you imagine being a farmer and being given thirty days to vacate your farm? Would you believe that within ten months of the first land purchases, the plant was producing munitions?



PENSION LEGISLATION PUT ON HOLD

The Ohio Retirement Study Council Chairman, **Senator Keith Faber** (Rep-Celina) has put any pension legislation on hold until next year. He had stated that he would hold public hearings this August, September and October around the state to get public input on proposals to strengthen the financial condition of the five pension systems.

If these ORSC meetings take place, we need to be present to voice our support for the STRS position to insure the long term solvency of our pension system. Our concern stems from the distinct possibility that persons will be there that will push for the Defined *Contribution* Plan that is in opposition to our current Defined *Benefit* Plan that most of us support. We need to be alert to what is happening even if the legislation is put off until next year.

On a positive note, I am really pleased to announce that the referendum vote on SB5 will in fact be placed on the ballot where a "yes" vote will mean that you approve of keeping it, and a "no" vote will be a rejection of SB5. **Jon Husted**, the Secretary of State for Ohio has listened to the public and has agreed to the verbiage that we believed was the clearest way to present it on the ballot. Don't hesitate to thank him for this very important move.

TIPS FOR CONTACTING GOVERNMENT OFFICIALS:

Keep the message short, legible and unemotional.
 Mention a bill or issue by name or number. State your purpose in the first paragraph.
 Be clear and factual in stating your concerns.
 Make it personal—how does the issue affect you, your home, your workplace, your children.
 Ask for a response. Include your name and street address, even if you email, because some offices only reply through the post office.

CROOKS CRAM PHONE BILLS WITH BOGUS CHARGES

When **Ruth Weigand** and I sat together at the Executive Board meeting, we discussed a scam ring up a charge on your bill for a service you we had seen on the Today Show: Crooks Cram Phone Bills with Bogus Charges. What was the up for." scammer's modus operandi? Steal a little money from *a lot* of people.

There are two ways a con artist can get rich: Steal a lot of money from a few people or steal a little money from a lot of people. Crammers work on volume.

They bill telephone customers for small unauthorized amounts, sometimes as little as \$2 or \$3. "These charges don't leap off the page," says Lois Greisman, head of the Division of Marketing Practices at the Federal Trade Commission.

"They're banking on the fact that people are not scrupulous in reading their phone bills and if the amount is low enough, you'll miss it."

Cramming started in the 1990's when the local phone companies began billing for independent content providers businesseseverything from daily horoscopes to adult chat. That made it possible for crammers to

charge for services that were not requested or authorized.

"Crammers have all sorts of 'devious ways' to didn't want or didn't realize you were signing

Don't get crammed!

- * Block your account.
- * Tell your phone company to put a cramming block on your account to stop thirdparty charges. You should not have to pay a fee for the block.

- * Scrutinize your bills.
- * Check your past year's phone bills for unnoticed charges.
- * Demand a refund.
- * If you find a problem, dispute the charge with your wireless service.
- * Complain: Contact the FCC, the FTC, and your state attorney general.

The moral of the story: Read your telephone bill carefully!

EXECUTIVE COMMITTEE MEETING - July 14, 2011

LOOKING BACK ON AT MISSED OPPORTUNITIES by Norm Park



Have you ever thought back to an opportunity you should I brought several cards down from the attic and asked if I could have them. I was told yes; they were of no u

One missed opportunity recently occurred to me, and I could kick my behind for not taking up on it. Although, I wouldn't really advise the kicking part. First, it's quite impossible to do; but if you should succeed, something will become disjointed.

Though the regret part occurred to me recently, the missed opportunity happened many years ago. I had a summer job, which was a necessity for many young teachers.

We, the shop teacher and I, were doing some work reconstructing on an old house in Hiram. For some reason, I had to go through a trap door to get to the attic. Being somewhat a snoop, I couldn't help notice a box containing letters and postcards.

Upon looking at several of the cards, I discovered they were written by a young man who had taken a teaching position in Carpenter, South Dakota. The letters were written to his mother and were dated 1915. I couldn't help but read some of them.



Can you imagine South Dakota in 1915? I suspect you can imagine what he wrote about: the flimsy clapboard school; the pot bellied stove that fought bravely against the Dakota winds; the janitorial work done by him in the school and horse shed; and the plea for clothing left behind in "mild" Hiram. He wrote, "I have a negative of my school, and if you'd send the developer and the proper printing stock, I'll be able to make a photo." I brought several cards down from the attic and asked if I could have them. I was told yes; they were of no use to the owner. This is where the regret comes in. Why didn't I ask if I could have the whole box? A young man's life as a teacher in a somewhat untamed prairie state would make terrific reading.

I would have loved to know about his students, where he boarded, the people of Carpenter, water for the school, his food and transportation. That box would cover these and much, much more. I'm fearful they might have ended up in the fireplace, for paper to start the fire might have been more important than a bunch of letters from a young teacher out west.

Also in my own collection of odds and ends I have several documents showing the results of teacher examinations issued by the Portage County Board of School Examiners. The one before me now shows that **Miss Keyes** is of good moral character and is authorized to teach in Portage County for a period of six months starting March 24, 1866.

In the subjects she was tested on, 7 1/2 was her highest score out of a possible 10. Her lowest was 5 1/2 and that was in arithmetic. Let's not judge her too severely for I've seen a few of these tests, and they can be real doozies!

Mr. Picket and **Mr. Dudley** were her examiners, both names ringing a distant bell in my head. **Mr. Dudley** attached a five cent revenue stamp to the certificate and then initialized it.

What about sitting down and chatting for several hours with **Miss Keyes**? What a treat! I wonder if she left any letters behind...




THANKS FROM "WE ARE OHIO"
