HOW THE SCHOLARSHIP RECIPIENTS ARE CHOSEN

Are you curious about how the recipients are chosen? This year we had 16 applicants from 8 schools: Crestwood—2; Field—3; Kent Roosevelt—2; Ravenna—1; Rootstown—2; Southeast—1; Streetsboro—4; and Waterloo—1.

Jim Montaquila is the chair of the Scholarship Committee and he works very hard to see that all the Portage County Schools are contacted about the scholarships. Information is sent to the guidance counselors, with reminders sent to them before the deadline.

Once the applications come in, Jim sends a packet of each student's information to each of the people on his committee: Dave Gynn, Norm Park, Jan Fencl, Kay Wise and Lowell Myers and they go

through each one individually, ranking the students according to a rubric. Next the committee meets, they total the scores and determine the top six students. Jim then contacts all applicants and provides information and pictures for the newsletter. He contacts the families and makes arrangements for them to attend the luncheon.

Jim says he wants to thank **Edith Scott** and all the NEOMED proctors who earn the money to present these scholarships. Some scholarships also come from donations as well as bequeaths from past members' families.

PRESIDENT'S CORNER - KEEP ROLLING ALONG

Kathy Baker, a writer, a motivational speaker, wife and mom, recently had an article published in the Record Courier about taking lessons from the river. She put the river into personification mode and then compared our lives to the old river. She advised us to keep rolling along in spite

of trouble, turmoil, peace, calm, raging, or whatever our predicament.

I think this is clever advice since we seem to be having more and more turmoil from both some citizens and Mother Nature as well. What can we

do as members of the Portage County Teacher's Association? What can we do as citizens of the United States of America? What can we do in Ohio, or in Portage County, or in our city of residence, or in our own homes?

Well, we as a group must keep ever vigilant of the changing work in Congress. Now it seems just after we got the word that the public pension plan was safe for a few years, we now received word that there is a new bill being introduced at the federal level which could once again make changes to the public pension system.

Our Legislative Chair, Dan McCombs, can explain this bill in more detail; however, we must think about the advice of Kathy Baker and keep rolling along in spite of turmoil and danger. We must do what we can to let our elected officials know how hard we have worked to keep our pension system intact and how much it could cost the government if they want to support us instead of us being taken care of by our own pension system.

For example, in my case, if I were to lose my STRS pension, then the government would need to switch to paying to me social security benefits to which I qualify through my former husband, or switch to paying me my own full social security benefits which are now also off-set by my STRS pension.

I'm thinking that perhaps there are many other folks in a similar situation to mine concerning pensions. We need to remind the government that because we are pensioned enough, we can volunteer in many situations and even donate to some causes, which would cost the government even more without donations provided by citizens. So, Kathy thank you for the advice. We shall keep rolling along.

ONE STEP FORWARD—TWO STEPS BACK: AVOID FEDERAL INTERVENTION

Here I was hoping for a relaxed summer after three long years of fighting the STRS Pension battles. Dave Gynn sent me information regarding the Public Employees Pension Transparency Act (known as PEPTA). Devin Nunes, a Republican Representative of California and others introduced this legislation on April 18, 2013.

Currently state pension systems have rigorous regulations and accounting standards in accordance with generally accepted accounting principles. PEPTA creates a worrisome precedent regarding Federal regulation of state and local governments and taxation of their bonds. It does this by mandating a costly and complex layer of Federal reporting on top of what is already required.

The legislation also requires state and locals to report as though they are invested only in U.S. Treasuries, not the diversified portfolios actually in use. This will create a false picture of the true condition of public pension plans and mislead taxpayers, frighten investors, and confuse policymakers. Also, PEPTA does not lower taxpayer costs as suggested, nor does it increase transparency and understanding of pension systems.

Ohio has made positive changes in our pension system over the past few years. We don't need Federal intervention. It has also come to my attention recently that the Congress is revisiting the takeover of our retirement systems and potentially placing them under Social Security.

Please join me in letting our Representatives and Senators know that we are totally opposed to these two measures. I guess we will never be able to relax our vigilance when it comes to watching our leaders in our nation's Capitol.

I will keep you posted regarding any changes in the two above-mentioned pieces of legislation.

KNOW YOUR MEDICATIONS

What to ask. If your doctor has prescribed a new medication, make sure you understand how to use it. Here are ten things to know:

- 1. What are the brand and generic names of the medication? (For possible cost savings, ask if you can use the generic.)
- 2. When should you take the prescribed medication and how often?
- 3. Should you take your medication with or without food?
- 4. Are there any known interactions?
- 5. If you forget to take a dose or take too much by mistake, what should you do?

- 6. What are the possible side effects?
- 7. When should you start feeling better?
- 8. When should you stop taking your medication?
- 9. How should the medication be stored?
- 10. Where can you find more information about the medication?

NEOMED and PCRTA members have had a wonderful working relationship over the past 6-7 years. NEOMED needed proctors for the medical students' tests, and PCRTA was looking for a way to earn money for our annual future teacher scholarships. It was a perfect match.

NEOMED's Suzanne Hricko and PCRTA'S Edith Scott have worked together seamlessly. Suzanne gives Edith the schedule of tests, and Edith calls to match proctors to the schedule. NEOMED has given money to our scholarship fund commensurate with the number of hours proctored. Starting out with 500 hours for the first two years, then growing to 750 hours with the addition of the School of Pharmacy, and now up to 900 hours as the University has grown. In general, proctoring funds six \$1000 scholarships each year.

On May 16, NEOMED held it's First Annual Proctor Appreciation Reception. Many of the 40+ proctors attended the reception. Stephanie Lammlein, Director of the BIO-MED Academy gave an enthusiastic presentation and answered the many questions the proctors had for her. What a wonderful opportunity for students interested in the medical field to be able to use the boundless, diverse resources available to them at NEOMED.

Light refreshments were served and the proctors received blue bags with the logo of the new mascot for NEOMED— "Nate, the Walking Whale," who was just introduced on May 8, 2013. Mary Evelyn Shabino and Kay Wise had their names drawn and received gas cards as a thank you.

Suzanne Hricko, the Chief Proctor and Curriculum Specialist at NEOMED, echoed the thoughts of the NEOMED staff about our proctors when she said, "We couldn't do it without you." And PCRTA and our scholarship program could say the same about NEOMED.

MEETING MINUTES - Ruth Weigand, Secretary



Highlights from the last Executive Committee and the luncheon meeting are provided below. Many meeting details are included in other reports in this newsletter. EXECUTIVE BOARD MEETING - May 9, 2013

- --President **Helena Parry** presided. Fifteen members were present.
- --Corrected minutes from Recording Secretary **Ruth Weigand** were approved.
- --Corresponding Secretary **Barb Cribbs** wrote to former scholarship winners to see updates on their status.
- --Treasurer **Darlene Fetterhoff** reported a treasury balance of \$13,701.38 (Scholarship \$4,407.50 / Working checking \$4,893.88). Income and expense details are available from Darlene. The Stifel Nicolaus investment account balance is \$44,881.44 (life memberships 54.28% and Scholarship 45.72%).
- --The 2012 audit and federal tax forms were filed by **Alan Balog.** The status of our 501(c)3 application is still pending.
- --Post cards were mailed to members who still have not paid 2013 dues which must be sent to ORTA before July 1. PCRTA had to absorb the \$1 per person luncheon cost because the increase in price was not known. A decision was made to use the 50/50 drawing for operating funds.
- --Vice President **Georgia Darrah** announced that Randy Overbeck, author of *Leave No Child Behind*, will be our speaker. She reminded proctors of the reception at 10:00.
- --Ron Snowberger, ORTA Trustee, told of the recent ORTA board meeting where reports from districts and chapters were presented. He read our chapter report which summarized our activities. Read the entire report on our website. He serves on the ORTA legislative, public relations, and vision/goals committees.
- --ORTA has a power point presentation to be used with preretirement workshops. Ron requested the slides and related commentary. We received a request from Florida for a copy of the skit performed at our December luncheon.
- --Helena Parry and Dave Gynn attended the April 19 ORTA meeting for presidents, vice presidents, and membership chairs. ORTA's goal is increased membership.

- --Judy Morgan reminded members about the community service project to bring items for the animal shelter to the luncheon. She also announced that we will provide refreshments for the GED graduation at Maplewood Career Center on June 6.
- --Members have reported 1,700 volunteer hours from January through April. When it was suggested to honor members with volunteer hours, Judy said that most do not want recognition. School supplies will be collected in July and materials and/or money donation for the giving dolls in September.
- --Dave Gynn said the membership committee will deliver membership packets to retirees. One new retiree will receive a free ORTA/PCRTA membership.
- --Pat Mazzer had eye surgery; Dee Smith will send her a card. Other cards have been sent to ill members.

Edith Scott, Proctoring Coordinator, said there are 45 proctors who have been invited to a reception at 10:00 on May 16 in Meschel Hall.

- --Newsletter Editor **Pat Gynn** said 328 newsletters were printed. 318 were mailed and 85 were emailed to members. The cost of printing and mailing was \$402.38.
- --Nominations Chair **Jan Fencl** said the offices of Vice-President, Recording Secretary, and Treasurer will be elected and installed at the annual meeting in November.
- --Richard and Maryann Brockett reported that the preretirement workshop for active teachers will be in April 2014. There will be presentations from STRS and also ORTA/PCRTA. Financial planning was suggested for a separate meeting.
- **--Kay Wise** has scheduled blood pressure checks on July 18 before the luncheon meeting.
- --Georgia Darrah said the notice for the May luncheon meeting and the article about the KSU Fashion Museum appeared in the *Record Courier*.
- --Jim Montaquila said the Scholarship Committee (Dave Gynn, Jan Fencl, Norm Park, Kay Wise, Lowell Myers and Jim Montaquila) met on April 15 to review the applications. Although rubrics were used to rate and make a composite for selections, it was difficult to make a choice. The committee selected Sarah McClure, Kent Roosevelt; Kayla Tuma and Alexia Brewster, Streetsboro; Ashley Spangler, Waterloo; and Melody Smith and Samantha Cooper, Field.
- --Letters were sent to scholarship recipients, guidance counselors, and other applicants. The committee will discuss changes and present recommendations to the by-laws committee.

- --President Parry appointed Saroj Sutaria (chair), Jan Fencl, Ron Snowberger, Pat Gynn, and Jim Montaquila to the by-laws committee.
- --John and Sandy Kerstetter said there were 45 responses from members to the survey for social activities which included theater, music, Paskey tours, and museums. Activities should be scheduled shortly after luncheon meetings to promote participation.
- --Webmaster **Connie Evans** posted the purposes of PCRTA on the web site. They are to explore subjects of interest to retirees, to inform members of changes coming to health care and retirement benefits, to serve the community in many ways, and to provide scholarships to deserving students.
- --There was a discussion of ways to earn monies for our general fund. One idea was to pay for scholarship-related expenses from the scholarship funds. Scholarship funds have been used to pay for guests at the scholarship luncheons in the past. It was decided that the \$850 fee for filing the 501(c)3 would also be paid from the scholarship fund.
- --Since **Sarah McClure** cannot attend the July luncheon, it was suggested to invite her and her parents to the May luncheon, rather than present the scholarship to her at her school.

Kay Wise made a motion to adjourn, seconded by **Jan Fencl**. Motion carried.

PCRTA LUNCHEON MEETING - May 16, 2013

- --President **Helena Parry** welcomed everyone and called the meeting to order.
- -- Dave Gynn led the pledge of allegiance.
- --**Helena** welcomed scholarship recipient, **Sarah McClure**, and her parents.
- --She also welcomed **Elaine Lumley** and **Kathy Wilen** who became new PCRTA/ORTA members today. They were invited to lunch by **Kathy Lilley** and **Kathy Latimer**, who had their names put in a drawing for bringing a future member. **Kathy Lilley** won a gift certificate to Laziza's in the drawing.
- --President **Helena** announced that the Executive Board decided that 50/50 drawing will go to the general fund rather than the scholarship fund. **Dan McCombs** said the 50/50 drawing had \$116 with \$58 won by **Ruth Weigand**, part of which was donated to the animal shelter and for the purchase of Leave No Child Behind.
- --John Kerstetter from the social committee said that the social activity survey showed a high interest in theater productions, musical events, and Paskey tours. He said 20 were signed up for the Harry London factory tour.

- --Dave Gynn, membership committee chair, asked members to look at the chart on the table to see if they know anyone on the list of potential members and pick up a membership brochure to take to them.
- --Judy Morgan, community service chair, said there is a chart going around for members to write down their number of volunteer hours. She said June 6th is the GED graduation at Maplewood Career Center. She would like members to sign up to help and/or bake cookies.
- --Edith Scott, Proctor Coordinator, said that she is very proud of our team of proctors. We started with 19 proctors in 2007 with 57 tests and 435 hours. For 2011-2012, there were 114 tests with 869 ½ hours.
- --Edith said the proctors attended a Proctor Thank You Appreciation Reception by NEOMED this morning. The NEOMED vice-president thanked the proctors.
- --Everyone gave **Edith** a hand for her work with the scheduling and reminder-calling of the proctors. There will be an orientation in August for anyone who thinks they would like to proctor tests.
- --Edith said that proctors have covered all the tests except two in the last two years. The NEOMED staff did the proctoring today so PCRTA members could attend today's luncheon.

LOOKING BACK AT LIT CLASS AND HOW IT HAS CHANGED



I went to the basement recently to decide which old books to keep and which ones to ditch. One book in its faded green color caught my eye and immediately brought back some old



memories. It was a lit book (published 1947) that I had used in my English classes. It was rather drab by today's standards--hand-drawn illustrations, no photos, no color. In looking over the stories, it struck me that very few of them could be used in a modern day text.

For instance: The "Old Man and Jim" by James Whitcomb Riley. An old man takes young Jim under his wing when



the boy twice returned home with wounds suffered for the Union cause. Each time, the old man cared for him and got him back into the ranks. It is a touching story, but today it could be misconstrued. An old man and a boy?

It certainly (snicker, snicker) gives off unsavory vibes. No, Mr. Riley, we can't use your story.

Another story which probably wouldn't make it into a modern text was about a rancher whose cattle were being killed by a grizzly. He had several faithful hounds who were good trackers but certainly no

match against a huge bear! So there was quite some excitement when the rancher added (at a huge expense) a fierce bulldog to the pack. If and when the grizzly was trapped, the Terrible Turk would be a great asset in closing out this chapter.

In time the bear was trapped and the hounds rushed in. So did Turk—not to go after the bear, but to attack the lead hound whose position in the pack had caused intense jealousy in the bulldog. After mauling the hound near to death, the rancher separated Turk from the fray, lead him over a rise, and a gunshot was heard. A good yarn but a little raw for today's younger teens. Killing bears and dogs just won't do.

Another story from the same text, which might not make the grade today, is Jack London's "To Build a Fire." An old dude in the Yukon decides to go out and check on trees for a possible lumber harvest come summer. It's around seventy below zero. He gets along fine until he steps into one of those strange never-freezing

springs which hides under the crust. He is wet to the knees and his leather boots instantly turn to steel sheeting. He panics and runs briefly on lifeless stumps, slumps into a soft blanket of snow and dies. The man showed poor judgment in venturing



out at that temperature and as a result paid the price. Death by freezing might be a little tough on today's eighth graders. Sorry, Mr. London.

So we live in an ever-changing world. What was acceptable yesterday is frowned upon today, and vice versa. And nowhere would that be more starkly apparent than comparing today's classrooms with those of sixty-plus years

ago. I'm not positive; it's just a suspicion.


