

## Portage County Retired Teachers

### WELCOME BACK TO LIFE, DOROTHY FULDHEIM

Remember Dorothy Fuldheim? Who could forget her. She was the feisty, outspoken journalist and television broadcaster who worked for The Cleveland Press and WEWS-TV. She was the first woman in the United States to host her own television show and to anchor a television news broadcast as well. She has been referred to as "The First Lady of Television News."

During the '20's, Fuldheim moved to Cleveland where she began her theatrical, lecturing, and broadcasting careers.

She began her television career at age 54 when she joined the staff of Channel 5 in Cleveland in 1947. She traveled widely to cover a variety of news stories, and was regarded as a broadcaster of national importance.

In 1959, she began to formulate her own newscast in response to the new "Eyewitness News" which was the first half-hour newscast in the country. She centered her newscast around her interviews, a general overview of the news, and her commentaries (during which the very opinionated Fuldheim frequently inserted her own opinions about the stories).

Fuldheim, recognizable for her fiery red hair, was well known for her sometimescontroversial opinions. She was not shy about supporting unpopular causes nor in voicing her opposition if she disagreed with a guest.

On May 4, 1970 while live on the air,



she made this statement regarding the actions of the Ohio National Guard during the Kent State shootings, "What is wrong with our country? We're killing our own children." Upset that she referred to the shooting of four students as murder, there were many calls from viewers for her to resign.

Fuldheim died in 1989, but she will be brought back to life for the day by Carol Starre-Kmiecik who portrays a number of famous women in her one-woman shows. She has been performing her characters on stage for over 35 years.

Starre-Kmiecek has a Degree in Speech and Theatre Arts from Baldwin-Wallace College and studied Improvisational Theater at Chicago's Second City for two years. Join us as she brings Dorothy Fuldheim to life right in front of our eyes.

I knew that many individual retirees delivered meals (yours truly for 25 years), but I had no idea that our own association sponsored a delivery program.

Also from early 1992, we learn there was a contest to find a new name for our newsletter. The two winners were **Bentley Hurd** of Ravenna and **Margaret Prichard** of Kent. Their reward was a free luncheon at an upcoming meeting. The winning name (pant, pant) was-you guessed it—The Desk Top. As you may or may not know, prior to 1992, our group's publication had the ungainly handle of The Portage County Retired Teachers Association Newsletter, Ralph Moore, Editor.

Volunteering can lead to new learning skills.


- Volunteering can help you deal with some of your personal problems.

#### Safety Tip about Security Fraud by Kay Wise, Informative & Protective Services Chair

At the last board meeting, **Art Fesemyer** told me a very informative story about his experience with fraud. The following narration is in Art's own words:

I had a phone call from a company in California about a shipment the company was about to make to my home address. I had not ordered anything from this company ever, so I immediately called the bank where I had my credit card account.

The bank asked me if I had used the card at Giant Eagle, and I told her I had. Then they asked if I had charged a call to Mexico, and I hadn't. So we canceled the card.

There were 48 packages that had been charged to my card and delivered by the post office. The postmaster had told me just to mark them "refused" and return them to the post office.

In addition, Fed Ex left a package on the porch that I returned, and another Fed Ex delivery person asked me to sign for a shipment from China that I also declined to sign. My bank sent me a new card. When the statement on the old card arrived, three of the purchases were mine and the rest, about 50, were listed. I was instructed to mark them "fraud" and return the



statement to a branch of my bank that investigates these cases.

The moral of the story is if you get calls about products you did not order, please call your credit card provider immediately. If you get packages you did not order, mark them "refused" and return them to the post office. If you get a statement with items you didn't order, mark those items "fraud" and return the statement to the credit card provider. Kay

Editor's note: When I talked with Art recently, he told me that someone had also tried to order something on his Amazon account and asked to have it sent to a different address, but Amazon contacted Art to check about it before they did it. Guard your personal card numbers carefully!

#### **EXECUTIVE COMMITTEE MEETING** – July 9, 2009

-President **Ray Troxtell** called the meeting to order with 14 members present.

-Legislative Chair Dan McCombs discussed the ongoing discussion at the state level regarding Governor Strickland's plans for PERS members pension and health care and how it may affect our STRS plans.

-Treasurer Darlene Fetterhoff gave the finance report. She announced that the Teresa Bica family will award a \$1000 scholarship, and the Mabelle Appley family will be awarding two \$1000 scholarships at the luncheon.

-Darlene announced we have three new members: Joseph Vince Kocin, Bonnie Oliver, and Judy Bills.

-Scholarship Chair Jim Montaquila thanked the people on his selection committee: Harry Bowman, Jan Fencl, Dave came from money earned by PCRTA proctors. Gynn, and Norm Park. Jim, Dave, and Ray went to Windham, Garfield, and Kent to present the scholarships at student recognition programs.

-ORTA Trustee Dan McCombs said that STRS is looking at reducing the COLA and at requiring teachers to teach longer before retiring. There is a need for letters to be sent to Ann Hanning, Director of ORTA, for support for paying money from REO-PAC for HPA expenses to support our pension funds. ORTA is proposing to lower the number of Trustees to 10 from 19.

-Community Services Chair Judy Morgan thanked the members who baked and served refreshments at the GED graduation at Maplewood.

-Edith Scott reported that NEOUCOM is working on a pilot program for giving tests online with students using their own computers.

-Telephone and Transportation Chair Saroj Sutaria asked for someone to take calls while she is on vacation. Ruth Weigand volunteered.

-Publicity Chair Evelyn Park reported that she had arranged to have a newspaper photographer at the meeting to take pictures of the scholarship recipients.

-Webmaster **Connie Evans** reported that our domain name and privacy domain have been renewed.

-Ray announced for Retirement Planning Chair Ria Mastromatteo that the seminar for retirees will be Oct. 21, from 5-7 at Western Reserve Public Media. Brochures will be sent to the school and by email. Less Bennett will take phone calls or teachers can register online or through the mail.

#### LUNCHEON MEETING – July 16, 2009
